ALL BOOTHS, NEEDING ELECTRICITY, MUST SUPPLY THEIR OWN EXENSION CORDS TO THEIR APPLIANCES. NO BOOTH WILL BE ALLOWED TO SET UP WITHOUT THE PROPER EQUIPMENT. ONCE VENDOR'S NEEDS HAVE BEEN ASSESSED AND THEIR PLUG HAS BEEN OK'D; BY COREY CALHOUN OR DAWNE SMITH; THEY MAY THEN ATTACH THEIR CORD.

SPACES WILL BE ASSIGNED ON A FIRST PAID BASIS. NO CASH OR CHECKS WILL BE ACCEPTED ON THE DAY OF SET UP.

Vendor Rules

ALL BOOTHS NEEDING ELECTRICITY, INCLUDING ALL EXENSIONS TO FRYERS, CROCK POTS, SKILLETTS AND MICROWAVES, MUST HAVE AT LEAST A 60 AMP BREAKER AND A #8 LINE FROM THE BOOTH. NO BOOTH WILL BE ALLOWED TO SET UP WITHOUT THE PROPER EQUIPMENT. VENDORS ARE RESPONSIBLE FOR CONNECTING THEIR 220 ELECTRICITY.

SPACES WILL BE ASSIGNED ON A FIRST PAID BASIS. NO CASH OR CHECKS WILL BE ACCEPTED ON THE DAY OF SET UP. BOOTH SPACE RENT AND ELECTRIC FEE MUST BE PAID IN ADVANCE WITH THE APPLICATION NO LATER THAN March 1, 2024.

ONE PARKING PASS WILL BE ASSIGNED PER VENDER.

1. VENDORS MAY CHECK IN AND SET UP APRIL 11, 2022 FROM 9 AM TO 5 PM IN FRONT OF THE BATTLEFIELD HALL. PLEASE DO NOT ENTER GROUNDS OR SET UP A BOOTH BEFORE THE DESIGNATED TIME. **You must check in with Casey Jones before setting up!!!!**
2. BOOTHS MUST BE REMOVED FROM THE GROUNDS AFTER CLOSING SUNDAY. EACH VENDOR IS RESPONSIBLE FOR KEEPING THEIR AREA CLEAN AT ALL TIMES. TRASH SHOULD BE PLACED IN THE DUMPSTERS PROVIDED. ANY VENDOR WHO DOES NOT COOPERATE WILL NOT BE INVITED BACK.
3. BOOTH SPACES WILL BE ASSIGNED BY THE RE-ENACTMENT COMMITTEE.
4. EACH ORGANIZATION SHOULD DISPLAY A SIGN THAT IDENTIFIES THEIR BOOTH.
5. EACH ORGANIZATION WILL BE RESPONSIBLE FOR SET UP AND REMOVAL OF ALL EQUIPMENT. STAKES SHALL NOT BE DRIVEN INTO THE ASPHALT.
6. EACH ORGANIZATION IS RESPONSIBLE FOR ITS OWN SALES AND CHANGE FUND. COMMISSION WILL NOT BE CHARGED ON SALES. THE PAYING OF LEGAL SALES TAX IS REQUIRED.
7. ALL REASONABLE CARE WILL BE EXERCISED. NEITHER THE AMERICAN LEGION NOR THE BATTLE OF PLEASANT HILL COMMITTEE WILL BE HELD LIABLE FOR LOSS OR DAMAGE TO ANY PERSON OR THEIR BOOTHS.
8. ELECTRICITY WILL BE AVAILABLE DEPENDING UPON VENDOR REQUIREMENTS. PLEASE LET US KNOW WHAT SIZE SERVICE IS NEEDED FOR YOUR APPLICATION. ELECTRICIANS WILL BE ON HAND TO ENSURE INSTALLATION IS DONE PROPERLY. IF SAFETY REQUIREMENTS ARE NOT FOLLOWED, THE BOOTH WILL NOT HAVE ACCESS TO ELECTRICITY. **VENDORS ARE RESPONSIBLE FOR THEIR OWN POWER CORDS.**
9. LIMITED WATER HOOK-UPS WILL BE AVAILABLE. ICE WILL BE AVAILABLE TO PURCHASE AS NEEDED.
